## RULES OF THE RANGE

*Note: By submitting your signed application for membership you are acknowledging that you have read, understand and agree to these rules.*

**The following rules are intended to promote safe and fun archery competitions consistent with HCB's obligations to the property owner and to conform with applicable law. The goal is to have fun with archery in a family friendly environment. Please remember that there are often children around during our events and conduct yourselves accordingly.**

1. No Firearms are allowed on the property.
2. No consumption or possession of alcoholic beverages is allowed on the property. HCB has and will exercise the right to ask anyone who appears to be impaired by alcohol or drugs to leave any tournament.
3. No smoking on the property except in designated areas. None of these designated areas are located on the tournament course.
4. The combination to the gate **must not be given to anyone**. This is a paid Full Membership privilege only.
5. No broad heads may be used.
6. No hunting is allowed on the property.
7. No overnight camping is allowed on the property.
8. No illegal activities are allowed on the property.
9. All members and guests must sign the Guest Agreement prior to participating in 3D shoots.
10. The gate must be closed at all times; there are cows on the property, so please do not leave the gate open any longer than necessary to pass through it.
11. No containers or trash (including cigarette butts) will be left on the range: please use the trash cans provided.
12. Vehicles must remain in designated parking areas. If special transportation provisions are needed, please consult an acting officer.
13. All minors on the property must be in the presence and active oversight of a responsible adult.
14. No trees will be cut, removed, or impacted in any way without specific written permission from the Lessor.
15. No Crossbow on the course or practice range.
16. **Violation of any of these Range Rules may be grounds for your removal from the range and/or revocation of your Membership.**
